We confirm that our films are in compliance with Regulation (EC) No 1907/2006 (REACH).

REACH regulates the domains of Health (product safety and consumerism) as well as Environment and is a single system for old, new, produced or imported substances in the European Union.

The REACH Regulation on European Union level brings different obligations within the supply chain for each link to the production, to the import for substances as such or substances in mixtures and requires an evaluation of substances related to respective application.

There is a registration obligation for all produced and imported substances > 1 t/a. The registration deadlines are 30.11.2010 for substances >1000 t/a, 31.05.2013 for substances >100 t/a and 31.05.2018 for substances >1 t/a.

Within the European Union only substances and mixtures are used, which are either registered, pre-registered or where no registration is necessary.

At the current time we assume that our products fulfil the requirements of REACH and do not expect a restriction in deliverability. If changes should arise we will inform you immediately.

ECHA's Member State Committee identifies chemical substances for the Candidate List of substances of very high concern for authorisation. ECHA will include these substances in the Candidate List after evaluation. Decisions on the need to subject these substances to authorisation will be taken later.

No SVHC substances according article 57, identified on the latest updated candidate list from 10.06.2022, are contained in our articles above 0,1 % (weight by weight).
